**CORRECTIVE CERTIFICATE OF AMENDMENT TO THE
DECLARATION OF COVENANTS AND RESTRICTIONS
OF
COBBLESTONE COUNTRY CLUB
(correcting scrivener's error)**

The Declaration of Covenants and Restrictions of Cobblestone Country Club is recorded in the Public Records of Martin County, Florida, at Official Records Book 821, Page 729 et.seq., and was amended at Official Records Book 973, Page 1467 et.seq., and Official Records Book 2301, Page 534, et.seq. The same Declaration of Covenants and Restrictions is hereby amended as approved by the members by a vote sufficient for approval.

1. Section 3.11 is hereby amended.

3.11 Surface Water Management System. The Association is responsible for the Surface Water Management System ("SWMS") described in Permit Number 43-00432-S (Applications: 12148-F-03, 900102-5, 890222-4, 890327-11, 12308-DD) of the South Florida Water Management District ("District"). The SWMS is owned by the Association. The Association is responsible for assessing and collecting fees for the operation, maintenance, and if necessary, replacement of the SWMS. Any amendment proposed to these documents which would affect the SWMS, conservation areas or water management portions of the common areas will be submitted to the District for a determination of whether the amendment necessitates a modification of the District permit. If a modification is necessary, the District will so advise the permittee.

(All other provisions of Section 3 are unchanged)

2. The foregoing amendment to the Declaration of Covenants and Restrictions of Cobblestone Country Club was adopted by the members by a vote sufficient for approval.

3. All provisions of the Declaration of Covenants and Restrictions are herein confirmed and shall remain in full force and effect, except as specifically amended herein.
